Set up will be allowed from 7am to 11am on the day of the festival and each vendor is required to remain open for business until 6pm. You may set up the night before but at your own risk. We will not be responsible for lost, damaged or stolen merchandise.

**Licenses/Certifications:**

A certificate of insurance is required with Long Beach Merchants Association listed as an additional insured. General liability must be at least \$1,000,000.

The City of Long Beach requires Vendors to be in compliance with all applicable regulations regarding their products. If you gross more than \$12,000 a year (or, if you gross less but need one or more specialty licenses), you must obtain a Master Business License from the State of Washington Department of Licensing (DOL) for \$15. You may need one or more specialty licenses; make sure to apply early. Please indicate below the licenses, certifications, and/or permits you have. If approved, you will need to include a copy of each with your paperwork. Please keep your licenses, permits, and certifications current. You are responsible for also bringing copies to the festival.
